Magellanic Technologies (Pty) Ltd ("we", "us", "our") is committed to protecting your privacy. ## 2. How We Use Your Information

We use the information we collect to provide and improve our Services, including but not limited to:

- **Service Delivery:** To provide the functionalities of the Services, including collecting and analysing BESS data to optimize performance and energy management.
- **Account Management:** To manage your account, process transactions, and maintain your subscription to the Services.
- **Customer Support:** To respond to inquiries, troubleshoot issues, and provide customer support.
- **Data Analytics:** To analyse data collected from your BESS for the purpose of improving the Service, enhancing system performance, and generating reports.
- Marketing and Communication: To send you promotional materials or updates about our Services, but only if you have opted in for such communications.
- Compliance: To comply with applicable laws and regulations, such as data protection and cybersecurity requirements.

# 3. Sharing Your Information
